OUR WORK REHABILITATION & ASSISTANCE

MEDICAL

The medical assistance was focused on the physical after-effects of torture. Following diagnosis by a general practitioner, the needed external referrals were provided for consultations with relevant medical specialist and for diagnostic investigations. Then needed, patients received free of charge medications.

PSYCHOLOGICAL & PSYCHOTHERAPY

Psvchological assistance was performed through: 1) Identification of beneficiaries' problems and needs through interviews and psychological tests; 2) Documentation of cases using the approved tests; 3) Providing psychological counseling and other support to improve their psycho-emotional status; 4) Initiation, performing and monitoring of the individual and group therapeutic sessions; 5) Participation at the co-therapy sessions and informative meetings for our beneficiaries; 6) Monitoring and evaluation of the patients' psychological problems with management of the cases; 7) Use and development of the multidisciplinary team work principles, in order to assure a positive psychological climate and a high efficiency of each team member. Mental Health Department professionals used the following evaluation tools: Hamilton Depression Scale, Taylor and Hamilton Anxiety Scales, Beck Depression Scale, Harvard Trauma Questionnaire (Cambodian revised version, in our translation and adaptation) and other tests.

SOCIAL

The SOCIAL ASSISTANCE was focused on the following activities: 1) determining eligibility and assessment of clients' individual needs after registration in working list; 2) social counseling and support in the solving of their problems; 3) providing of needed information about the existent available services and opportunities; 4) helping beneficiaries to

obtain assistance or compensations from some of the state institutions; 5) counseling and support in finding a job or an occupation. Our Social Assistant has been involved in the selection of eligible beneficiaries and registering in working lists, as well as in the case management, drafting or adjustment of the general intervention plans for clients. The needed support in increasing of social functioning depends on the problems faced by our clients.

LEGAL

During 2014 the legal assistance was focused on: 1) beneficiaries' counseling and the monitoring of the legal status; 2) monitoring and mapping of the evolution of the cases started against the perpetrators; cooperation with other NGOs and lawyers who assisted our beneficiaries and/or represented them in Courts; 4) legal counseling and legal supervision of cooperation and communication with other institutions. Legal counselor offered the needed support to clients and their relatives, according to their specific needs and monitored their legal status. In cooperation with their lawyers and other NGOs developed the defending strategies for our clients. The needed counseling, the analysis of documents and situation of the cases, the preparation of the needed petitions and claims in various instances, or the support in getting appropriate attorney lawyers, have been continuously provided. The needed consultations were also offered to our beneficiaries who sent their complaints to ECtHR on art.3; or in the negotiation process upon the communication of their cases to Moldovan Government.

MEDICAL DOCUMENTATION

RCTV "Memoria" continuously provided necessary documentation of torture and other degrading treatments cases which was based on the comprehensive model of treatment our institution provides. RCTV "Memoria" is the only institution in Moldova where survivors of torture can receive appropriate medical certification, in accordance with the Istanbul Protocol.
